ACCSC's Executive Director Testifies at House Education Committee Hearing

"Strengthening Accreditation to Better Protect Students and Taxpayers"



On April 27, 2017, ACCSC's Executive Director, Dr. Michale S. McComis, testified before the House Committee on Education and the Workforce at the full-committee hearing "Strengthening Accreditation to Better Protect Students and Taxpayers." As part of his testimony, Dr. McComis discussed accreditation and the contributions that it makes towards enhancing the quality of education in the United States, outlined the distinct approaches to quality assessment deployed by ACCSC, and offered

several ideas to members of Congress regarding ways in which accreditation can be strengthened and improved. As noted by Dr. McComis in his testimony, "Accreditation, as the sector with the principle responsibility for quality assurance in higher education, needs to work earnestly toward moving the discussion of accreditation's effectiveness from that of skepticism to confidence." Dr. McComis further noted, "There is no doubt that the enterprise of accreditation is evolving and must continue to improve, and that accreditors must continue to embrace innovative approaches to education while balancing the need for greater accountability."

Duane Kramer, Chairman of the ACCSC Commission, noted "The Accrediting Commission was incredibly pleased to have the opportunity to actively participate in the dialogue with members of Congress on ways to strengthen accreditation. ACCSC will continue to pursue opportunities to discuss the important role that accreditation plays and to share how ACCSC-accredited institutions are providing a high quality educational experience for hundreds of thousands of students each year."
