Subject: Revisions to the ACCSC Standards of Accreditation

Over the period of July 1, 2010 through July 1, 2011, the Accrediting Commission of Career Schools and Colleges ("ACCSC") made several revisions to the *Standards of Accreditation*. In order to ensure that accredited institutions have complete and up-to-date knowledge of the Commission's current requirements, a revised version of the ACCSC *Standards of Accreditation* dated July 1, 2011 is now available on the Commission's website at www.accsc.org.

The Commission would also like to remind institutions that revisions made to *Section IV & Section V, Substantive Standards, Standards of Accreditation* are now in effect (July 1, 2011) as set forth in the April 22, 2011 Accreditation Alert.
